PRESERVING HISTORY & CULTURE

WORK IN PROGRESS

Preservation & the Future of Flat Top Manor

This was a landmark year in the effort to safeguard Flat Top Manor at Moses H. Cone Memorial Park, as the installation of a new fire suppression system is now complete. Drawing water from a roughly 30,000-gallon tank, and extending throughout the building as well as its expansive porch, the system is the first comprehensive fire solution to be installed in the dwelling's almost 120-year history.

In October, the National Park Service's Denver Service Center joined the process of restoring the manor, creating a plan to extensively rehabilitate the building's exterior. The repairs will include the replacement of cedar shingles and supportive columns, as well as restoration of the doors, windows, siding, gutters, and additional features.

As the planning, design, and construction management office for the national park system, the Denver Service Center has been responsible for some of the largest park projects, including preservation efforts at the Jefferson and Lincoln memorials, and the construction of the Parkway Visitor Center in Asheville, North Carolina.

To date, your gifts have funded nearly 90 percent of the project's total \$3.6 million cost. Together, we will preserve this priceless Parkway icon for future visitors and stewards to enjoy.

PROJECT COMPLETE A New Flume for Mabry Mill

Thanks to your generosity, this fall we finished a number of repairs at historic Mabry Mill, milepost 176. In the early 1900's, Ed and Lizzie Mabry proved their ingenuity and resourcefulness when constructing a web of ditches, flumes, and sluices throughout their land to consolidate the area's limited water supply. With the completion of the new flume, water can once again turn the mill's wheel. Additionally, new shake roofing was installed on a number of historic buildings at the site, ensuring that these structures can survive to be sources of education and inspiration for years to come.

PROJECT COMPLETE Modern Visions, Mountain Views

From August through November, Blowing Rock locals and visitors were invited to delve into the history of the Cone family through the exhibit *Modern Visions, Mountain Views: The Cones of Flat Top Manor* at Blowing Rock Art and History Museum.

The exhibition was a collaboration between the Foundation, National Park Service, and museum. It explored the marvel of Moses and Bertha Cone's visionary country estate, from the orchards with more than 30,000 apple trees to Flat Top Manor's modern conveniences, including hot and cold running water, gas lights, telephones, and central heat. By featuring stories from family memories and letters as well as belongings, *Modern Visions, Mountain Views* offered a window into the personal and cultural interests of Cone family members.

By sharing a deeper understanding of the Cones' impact on the High Country of North Carolina, the Foundation highlights the importance of protecting the estate.

ENHANCING VISITOR EXPERIENCES

Millions of people from across the globe visit our park each year. Your support plays a key role in making their experience safe and memorable. Whether they get the chance to enjoy a homestyle meal at Bluffs Restaurant in the near future or receive the quick response they need during an emergency, these are the moments that will stay with them.

PROJECT COMPLETE Streamlining Safety

When a call comes in to Blue Ridge Parkway dispatchers with the National Park Service, there are hundreds of scenarios they can face, ranging from a report of injured wildlife to a vehicle accident.

Until this fall, their role was even more complicated because they relied on hand-written logs and managed four to six computer programs to address any situation at hand. Thanks to your support for safer Parkway experiences, this branch of the law enforcement team is now using a new Computer Automated Dispatch (CAD) system. The system streamlines how dispatchers assist rangers or local emergency responders, with access to immediate mapping, site details, and background information.

The system is enabling the dispatch team to increase its focus and efficiency by more than 50 percent, allowing each member to provide better

service and more attention to each call.

The project was a collaboration between two parks, the Blue Ridge Parkway and Great Smoky Mountains National Park, and two partner groups, the Foundation and the Friends of the Smokies, which provided funding for both parks to install the system.



ONGOING EFFORT Renew the Views

The Renew the Views initiative continued this year, with NPS resource managers restoring vistas between Craggy Gardens, milepost 364, and Cold Mountain, milepost 412. Highlights include the clearing of the Pink Beds Overlook, which uncovered a long-lost view of Looking Glass Rock. Efforts take place under the direction of the Parkway's resident landscape architect, with the goal of being minimally impactful to wildlife.



NEW BEGINNINGS Happy Days Ahead for Bluffs Restaurant

For so many people who enjoy fond memories of Bluffs Coffee Shop, the stories go beyond the ham biscuits, pan-fried chicken, and berry cobbler. A big part of the charm of stopping in for a home-style meal was the welcoming staff, including server Ellen Woodruff Smith, who worked at The Bluffs from the day it opened on May 31, 1949, to the day it closed on November 1, 2010.

"I never met a stranger," says Ellen, who greeted tourists from all 50 states and loyal locals with her beautiful Alleghany County accent and expressions. In her 61 years working at the popular Parkway spot at Doughton Park, she saw familiar faces come back time and again and children grow up each season, eventually returning with their own children. Ellen confesses she "spoiled every youngin' I could."

And just as The Bluffs was a meeting place for family and friends, it was also the place Ellen met her husband, Paul. He recalls her as "beautiful but aloof." Still, he won her over and the two married in 1952. Paul became a regular face at Bluffs in his off time from working for the National Park Service to maintain the rangers' vehicles and heavy duty equipment. He wasn't just a frequent customer though, he helped with service at Bluffs Coffee Shop and the Lodge.

Today, Ellen and Paul, who are in their 90s, still receive Christmas cards from friends and customers

who frequented Bluffs Coffee Shop. The couple would like nothing more than to see it reopen, and thanks to your support, it's happening. A decade after Bluffs Restaurant closed, the beloved dining spot is slated to reopen in 2020.

To safeguard the significant investment of our Community of Stewards, the Foundation is in the process of securing a historic lease for the site, allowing for oversite of the new operation as well as the facility. Thank you to all of our stewards for your support. Without you, this wouldn't be possible.



PROTECTING NATURAL RESOURCES

The Blue Ridge Parkway gives us many powerful gifts, including the opportunity to explore the natural world. We are merely visitors in this vast landscape, while it is home to myriad plants and animals that contribute to the well-being of this diverse landscape. Your support is safeguarding this wild and wondrous place.



ONGOING PROJECT Wildlife Cameras

Your generosity funded the purchase of motion-activated cameras for the Parkway Wild project. Through this initiative, scientists and citizens led by Parkway Natural Resource Specialist Tom Davis have been able to monitor wildlife in remote areas of the park. This year, more than 75 camera "traps" were deployed throughout the Plateau and Highland districts, capturing roughly 32,000 images of 25 species. This wealth of data is a fantastic resource for scientists studying wildlife locations, habits, and populations. Parkway biologist Lillian McElrath also deployed cameras to monitor the park's culverts and drainage systems, where she observed a number of species using the passages to cross underneath the

YOUR GIFTS IN ACTION Thwarting Poachers

In 2018, Law Enforcement Rangers deployed a network of devices to assist them in watching over rare plant species at remote locations. Dubbed "force multipliers," these devices alert rangers to potential threats within the thousands of acres that make up the Blue Ridge Parkway.

Chief Ranger Neal Labrie reports that his team is able to cover more ground and get a jump on emerging poaching efforts thanks to the devices. For instance, they were able to catch and charge a poacher for stripping bark from a stand of witch hazel plants, an attack on natural resources they had not seen before. Though the trees are not a threatened species, rangers are gaining awareness of what could be an emerging threat to the natural resources they protect.



road itself. In the future, this data could be used to engineer drainage systems that are more wildlifefriendly.

Additionally, a pair of cameras were set up to record video of wildlife activity at springs along the Parkway. These "bear bath tub" cameras have captured footage that is both insightful and entertaining, some of which can be viewed at the Foundation's Facebook page.

EDUCATION & OUTREACH

YOUNG STEWARDS

A Decade of Kids in Parks

The Kids in Parks program reached a number of exciting milestones during its 10th year engaging children. The anniversary, on August 24, was celebrated with the first National TRACK Trails Day, during which kids, families, and partners across the country participated in educational talks, guided hikes, rounds of disc golf, and more activities. The new annual event will give Trail TRACKers the opportunity to connect with each other and celebrate being unplugged and out in nature.

This year also brought the unveiling of the 200th TRACK Trail, located at Rocky Knob Picnic Area. The trail is one of two opened on the Parkway this year, with the other at James River Visitor Center. Twenty additional trails opened nationwide in 2019, including locations in Oregon, Washington, and South Dakota. And these trails are being put to good use: TRACK trails have been host to over one million adventures.

"Getting kids and families connected to our parks and public lands ensures we have the next generation of stewards to care for our nation's legacy," says Jason Urroz, Director of Kids in Parks.

CULTURAL CONNECTION Blue Ridge Music Center

In April, the Blue Ridge Music Center convened its first-ever conference to explore the theme of "Mill Towns and the Birth of American Music" as a way to further its mission to preserve and share the roots of mountain music. Guest speakers, authors, and performers traced the thread of musical traditions that were born out of mill and factory towns in the late 19th and early 20th centuries. It was a period of migration from the countryside to the growing cities and towns, when people searched for work in factories and textile mills. They brought their instruments and songs, and the blending of traditions gave rise to new musical forms and a growing music industry.

The Music Center also produced an outstanding summer concert season in 2019. While there were many great moments, magic was in the air during a performance with Mandolin Orange and the Winston-Salem Symphony's Chamber Orchestra. More than 1,700 attended the show, making it the third largest audience in the history of the Music Center. The mood was set from the first note as the orchestra played Aaron Copeland's Appalachian Spring with Fisher Peak in the background. Mandolin Orange followed with a set of their own folk-based music featuring beautiful harmonies, and the evening was capped off with the orchestra joining in on some of their original songs.

Your support for the Music Center through ticket purchases, donations, sponsorships, and volunteer time is helping to preserve a vital aspect of mountain heritage.


PROTECTING PLANTS Virginia Ward

At just 14 years old, Virginia Ward earned the Blue Ridge Parkway Youth Volunteer Award for her work to help protect native plant species in the park. Under the guidance of National Park Service Biologist Chris Ulrey, Virginia journeys off-trail, up steep rock faces and through dense flora, to access rare plants and gather data. The information she records will help to provide insight about the well-being of these plant populations, as well as assist in developing management strategies to protect each species.

She and her husband enjoy birdwatching at Ridge Junction Overlook and hawk watching in September at Mills River Overlook. They also visit the vertical bog near Wolf Mountain Overlook a few times a year. "The hiking trails along the Parkway are endless," Penelope says. "Craggy Gardens Pinnacle is the first place I take visitors because it is an easy, quick walk to the top with views that show them what Western North Carolina is all about."



After a 36-year career with the National Park Service, Gary Johnson is still taking care of the Parkway by renewing his "PLNR" (planner) plate each year. As a project manager, landscape architect, and section chief on major planning, design, and construction projects, he worked in 56 national park units in Alaska and the lower 48 states. From 1995 until he retired in 2011, Johnson served as the Parkway's Chief Landscape Architect and Planner. Gary was involved with the Foundation when the Parkway tag program was in development. In fact, it was his idea to incorporate the iconic overlook sign graphic that appears on the left side of each tag.





REMEMBERING A Parkway Love Story

Ray and Laura Pease shared a love story, and not just with each other. The Blue Ridge Parkway wove its way into their hearts, and became a touchstone in their life together.

After discovering the Pisgah Inn during a visit to the Blue Ridge Mountains in 1979, the couple returned each October to explore the Parkway. "Every year we would come and discover new trails and take some of the old trails," Laura says. They weren't shy about asking for recommendations for their next hiking or picnic spot. "Being Southerners, we talked to everybody."

When the couple decided to get married in 1986, Ray knew he didn't want a big to-do. Instead, they planned a simple ceremony with a justice of the peace and Ray's brother and sister-in-law as witnesses. Clad in plaid flannel shirts, Laura and Ray took their vows amid the autumn colors at Craggy Gardens, just beyond the Visitor Center.

In 2010, they said goodbye to Louisiana and made the mountains their forever home. And because of all the people they had met during their Parkway visits, they had a trove of friends ready to welcome them.

As they grew older, the two replaced some hikes with weekly drives. "We would turn the radio off.

"Riding along the Parkway, there is just so much to absorb." On their car, a Blue Ridge Parkway license plate read "DCT," for Dreams Come True.

After Ray passed away in June of this year, an outpouring of gifts came in to the Foundation in recognition of his love for the Parkway. And Laura honored one of his last wishes. Before resting his ashes at their church, she traveled with them to Mount Mitchell, with a stop at Craggy Gardens, so they could have one more Parkway journey together.

"I realized later, he did that to make sure I would go back without him," Laura explains. "The Parkway became part of us, and it gives me great comfort now."

REMEMBERING Eric Weigel

Everyone who knew Eric Weigel recognized from a very young age that he was remarkably intelligent and possessed a kind and generous spirit. According to his parents, Jayne Anderson and Larry Weigel, "Eric was always wise beyond his years; he was an old soul."

Growing up, Eric and his older brother, David, spent endless hours exploring and playing in the dense woods surrounding their home in Asheville. The family regularly packed up their pop-up camper and headed out for weekend stays in campgrounds along the Parkway.

Eric's connection to the outdoors continued to grow through camping, hiking, and later, kayaking. He attended many nature camps, including a summer experience at the Great Smoky Mountains Institute at Tremont, studying nature and environmental science. When Eric was 16, he participated in a rigorous Alaskan backpacking course with the National Outdoor Leadership School (NOLS). After that training, Larry and Jayne noted that their son left home a boy and returned a young man. Eric shared his love of nature and life in a high school presentation: "I feel God's presence in nature, in other people, in all things mysterious and beautiful, in the awe-inspiring world we inhabit and will never fully understand." While in college, Eric returned to NOLS and received his Wilderness Emergency Medical Training. This experience influenced his decision to pursue a career in medicine.

Larry and Jayne nurtured their son's innate curiosity, allowing him to fill his life with a richness of diverse interests and experiences. In addition to his outdoor activities, Eric was an accomplished pianist, a science scholar, a nature photographer, and an avid reader. He made room in his busy schedule for volunteer activities, including many hours at the WNC Nature Center, as he believed we all have a responsibility to care for people in need, the environment, and animals.

Eric would have been 29 years old this year. In June 2013, one month after graduating from Furman



University with a degree in chemistry, Eric died in a tragic kayaking accident during a camping trip in Idaho. Two years later, his family established the Eric Anderson Weigel Memorial Fund through the Community Foundation of Western North Carolina. Annual grants from the fund are given to organizations that reflect Eric's passions.

To honor Eric's belief that children need time in nature, the family sponsored our Kids in Parks program's TRACK Trail at the North Carolina Arboretum, just off the Blue Ridge Parkway at milepost 393 in Asheville. "The Arboretum holds many wonderful family memories," Jayne says.

Through the grant, the TRACK Trail received updated signage, trail navigation, and a new custom brochure. The family also provided scholarships for the next five years for underserved youth to attend the arboretum's summer camps.

"To have children see the wonder of nature, that was so important to Eric," Larry says. "To have young people become stewards of the environment is so critical."
