THE FOUNDATION ADDRESSES UNMET PARK NEEDS BY PROVIDING SUPPORT FOR INITIATIVES AND PROGRAMS ALONG THE 469-MILE ROUTE, INCLUDING HISTORICAL AND CULTURAL PRESERVATION, NATURAL RESOURCE PROTECTION, VISITOR AMENITIES, AND EDUCATION AND OUTREACH. THE ORGANIZATION'S MISSION INCLUDES ENGAGING A NEW GENERATION OF STEWARDS IN THE PROTECTION OF THE NATIONAL PARK AND ADDITIONAL PUBLIC LANDS.

TRACK TRAILS ARE DESIGNED TO ENCOURAGE CHILDREN TO BE PHYSICALLY ACTIVE AND HELP THEM BUILD MEANINGFUL CONNECTIONS WITH NATURE. IN TURN, THESE GOALS HELP INSPIRE THE NEXT GENERATION OF STEWARDS WHO WILL CARE FOR ALL PUBLIC LANDS, INCLUDING THE BLUE RIDGE PARKWAY.
